A RESOLUTION APPROVING THE USE OF INCOME OF THE ALANG-ALANG CAMPUS

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed Use of Income of the LSU Alang-alang Campus, as proposed.
