**A RESOLUTION APPROVING THE HIRING OF
ATTY. RYSAN C. GUINOCOR AS VSU LEGAL CONSULTANT
VICE ATTY. GLORIOSA C. GUINOCOR FOR THE PERIOD 01 JUNE 2011 UNTIL
31 DECEMBER 2011 SUBJECT TO EXISTING RULES, REGULATIONS AND
GUIDELINES GOVERNING SUCH AN APPOINTMENT**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, the Visayas State University needs the services of a regular member of the BAR to undertake the following:

1. *to review legal documents, contracts, MOAs;*
2. *to provide legal opinion to the Office of the President;*
3. *to notarize University documents;*
4. *to appear in court, in coordination with the Office of the Solicitor General (OSG), to protect the rights and interests of the University from any and all threats to its security; and*
5. *to represent the University and its employees when sued in their official capacity.*

WHEREAS, the Board of Trustees of the then Visayas State College of Agriculture (ViSCA) passed BOT Resolution No. 56, s. 2001 dated 23 May 2001 "*Approving the Hiring of Atty. Gloriosa Cayunda-Guinocor as Legal Consultant of ViSCA as approved by the Office of the Solicitor-General*";

WHEREAS, the Deputation of Atty. Rysan C. Guinocor as Special Attorney of the Office of the Solicitor General to appear for and on behalf of the University, is still being processed;

WHEREAS, the Board of Regents passed BOR Resolution No. 13, s. 2006 dated 21 February 2006 "*Approving the Increase in Consultancy Fee/Retainer of Atty. Gloriosa C. Guinocor*" *from P5,000.00 to P10,000.00 per month*";

BOR Resolution No. 83, s. 2011 – A Resolution Confirming the appointment of Atty. Rysan C. Guinocor as University Legal Consultant vice Atty. Gloriosa C. Guinocor, Subject to existing Rules, Regulations and Guidelines governing such an appointment.






