**BOR RESOLUTION NO. 88, s. 2016**

**A RESOLUTION CONFIRMING THE RE-EMPLOYMENT OF MR. REYNALDO V. DOSDOS AS CASUAL ADMINISTRATIVE AIDE VI IN THE VSU MAIN CAMPUS  
SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON SUCH  
APPOINTMENTS AND EFFECTIVE ON THE DATES INDICATED**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

**WHEREAS**, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "*to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University*";

**WHEREAS**, the Visayas State University has to regularly fill-up vacant positions with the most qualified candidates whenever it exists;

**WHEREAS**, there is one (1) vacant administrative position in the roster of the University, as follows:


One (1) casual item for the position of Administrative Aide VI (SG-6) – Main Campus


**WHEREAS**, the NAPB has determined that the aforementioned applicant to the vacant position is well qualified for said positions and is strongly recommended to the Board of Regents the hiring of Mr. Reynaldo v. Dosdos as casual administrative employees to fill-up the vacant administrative position.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the re-issuance of a casual appointment to Mr. Reynaldo V. Dosdos as Administrative Aide VI effective on the dates of the appointment.
