BOR RESOLUTION NO. 32, s. 2016

A RESOLUTION APPROVING THE REQUEST OF THE VSU ALANGALANG TO UTILIZE THE REMAINING BALANCE OF CY 2015 UNAPPROPRIATED COLLECTIONS FROM FUND 164 IN THE AMOUNT OF P7,127,599.52 FOR AUGMENTATION OF CAPITAL OUTLAY (CO) AND MAINTENANCE AND OPERATING EXPENSES (MOOE) *SUBJECT TO* EXISTING POLICIES AND GUIDELINES GOVERNING THE USE OF SUCH FUNDS AND PROVIDED THAT THE REMAINING BALANCE IN THE AMOUNT OF P628,779.12 BE IMMEDIATELY UTILIZED FOR THE REPAIR AND REHABILITATION OF THE AGRICULTURAL TECHNOLOGY BUILDING OF THE COLLEGE

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (f) of R.A. 9158 empowers the Governing Board *“to authorize the construction or repair of its buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties, including necessary supplies, materials and equipment...”*;

WHEREAS, the VSU Alangalang Campus would like to utilize said funds as follows:

A. Augmentation of Capital Outlay Funds, to wit:

1. P 800,000.00, for the construction of covered walk from Main Gate to Social Hall;
2. P1,278,156.01, for the construction of storage and comfort rooms in different offices of the New Administration Building;
3. P 384,683.83, for the construction of storage and comfort rooms for the Admin. Annex Building
4. P 500,000.00 for the rehabilitation of comfort rooms/septic tank in the College-Main Building;
5. P 500,000.00, for the rehabilitation of comfort rooms of Home Technology building;
6. P 487,158.16, for the construction of new guard house;
7. P 200,000.00, for the construction of Food Stalls/Canteen;
8. P 380,483.00, for the renovation of the Computer Laboratory;
9. P 126,539.27, for the repair of the Piggery Building;
10. P 108,080.70, for the repair of the new Library Building; and
11. P 633,832.80, for the rehabilitation of Motorpool Building.

B. Augmentation of MOOE Funds, to wit:

1. P 19,900.00, for costume rental;
2. P 83,937.05, for repair and repainting of benches around campus.

WHEREAS, the proposal was discussed and approved on the occasion of the 118th UADCO Meeting held last 13 June 2016 at Office of the Vice President for Administration and Finance, 2nd Floor, Administration Building, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the request for the VSU Alangalang Campus to utilize the remaining balance of CY 2015 Unappropriated Collections from Fund 164 in the amount of P7,127,599.52 for augmentation of MOOE and CO *Subject to* existing policies and guidelines governing the use of such funds and *Provided that* the remaining balance amounting to P628,779.12 be immediately utilized for the immediate repair and rehabilitation of the Agricultural Technology building of the College.
