## A RESOLUTION CONFIRMING THE LIST OF CANDIDATE FOR GRADUATION WITH LATIN HONORS OF THE VSU-VILLABA CAMPUS FOR THE 2<sup>nd</sup> SEMESTER SY 2007-2008

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

WHEREAS, the University Academic Councils of the Whole met last 12 February 2008 for the purpose of reviewing the list of candidates for graduation with Latin Honors of the VSU Villaba Campus for the 2<sup>nd</sup> Semester SY 2007-2008 and have found the list of candidates for graduation with Latin Honors to be in order and has recommended to the VSU Board of Regents the list for approval, provided that the candidates shall have complied with all the requirements for Latin Honors on or before the deadline indicated in the approved Academic Calendar for School Year 2007-2008.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the list of candidates for graduation for Latin Honors of the VSU Villaba Campus for the 2<sup>nd</sup> Semester SY 2007-2008 *provided that* the candidates shall have complied with all the requirements for Latin Honors on or before the deadline indicated in the approved Academic Calendar for School Year 2007-2008.
