BOR RESOLUTION NO. 10, s. 2007

A RESOLUTION APPROVING TO REVISE THE MASTER IN EDUCATION PROGRAM AT LEYTE STATE UNIVERSITY EFFECTIVE 1st SEMESTER SY 2007-2008

WHEREAS, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, the College Academic Councils of the College of Education and the College of Arts and Sciences of the Main Campus have reviewed and have favorably recommended the approval of the proposed revisions of the Master in Education (M.Ed.) program to the University Academic Council;

WHEREAS, the University Academic Council met on 06 February 2007 for the purpose of reviewing the proposed revisions in the Master of Education (M.Ed.) program and has determined that such an academic program is indeed in need of improvement as it is an important offering of the University and has favorably recommended to the University Board of Regents the revision of the Master in Education program, effective 1st Semester, SY 2007-2008;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the revisions of the Master in Education (M.Ed.) program in the Main Campus, effective 1st Semester, SY 2007-2008 *provided that* all other existing policies/requirements attendant to the offering on degree programs are strictly followed.
