**A RESOLUTION APPROVING THE SABBATICAL LEAVE APPLICATION
OF DR. MERLITA D. VELOSO FROM 01 JUNE 2012 TO 31 MAY 2013 PROVIDED
THAT THE SABBATICAL LEAVE GUIDELINES APPROVED BY THE VSU BOARD OF
REGENTS ARE STRICTLY FOLLOWED**

WHEREAS, the faculty and staff of state universities and colleges belong to the "closed career positions of the civil service" being scientific or highly technical in nature and as such are mandated to establish and maintain its own merit system;

WHEREAS, sabbatical assignment is granted to qualified members of the faculty to encourage study, investigation, research and to improve staff competencies for improved efficiency;

WHEREAS, Dr. Merlita D. Veloso, Associate Professor III, Visayas State University - Villaba Campus, Cagnocot, Villaba, Leyte has expressed her desire to conduct a research entitled "*The Role of CHED-Identified PIAs in Region VIII as Perceived by Students, Faculty and Stakeholders*";

WHEREAS, Dr. Merlita D. Veloso is proposing to conduct the research around Region VIII specifically in the five (5) Provincial Institutes of Agriculture (PIAs): ESSU-Salcedo Campus; NSU-Biliran Campus; UEP; NWSSU; and VSU-Villaba Campus from 01 June 2012 to 31 May 2013;

WHEREAS, Dr. Merlita D. Veloso possesses all the qualification requirements to do scholarly and creative work;

WHEREAS, the University Academic Personnel Board (APB) during its 6 March 2012 and 17 April 2012 discussed the merits of the proposed sabbatical research and is recommending to the VSU Board of Regents, the Approval of the Sabbatical Leave application of Dr. Merlita D. Veloso effective 01 June 2012 until 31 May 2013; and


WHEREAS, the University President is endorsing the same to the Board of Regents for Approval *provided that* the Sabbatical Leave guidelines approved by the BOR are strictly followed.






