BOR RESOLUTION NO. 53, s. 2011

A RESOLUTION APPROVING THE PROPOSAL TO INCREASE THE HONORARIUM RATES OF THE UNIVERSITY REVIEW CENTER SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH INCREASES

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Section 7, Item (a) of R.A. 9158;

WHEREAS, the University established its own Review Center with the objective of providing affordable but quality Review Services for the University's graduates to prepare them to the different Board Examinations given by the Professional Regulations Commission (PRC);

WHEREAS, the University Review Center has to co-opt some of the best faculty of the University to be part of the Center's pool of quality reviewers, to enable it to continue carrying out its objectives;

WHEREAS, there is a need to provide additional incentives to the Center's pool of Reviewers as a way of boosting their morale as they continue to put their time and effort improving the quality of the reviews provided by the Review Center;

WHEREAS, the Governing Board is convinced that the proposal has merit given the University's having produced board topnotchers as well as garnering a passing percentage which have consistently been above the national passing average.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposal to increase the honorarium rates of the University Review Center subject to existing rules, regulations and guidelines governing such increases.

PROPOSAL TO INCREASE THE HONORARIUM RATES
OF THE UNIVERSITY REVIEW CENTER

(As approved by the University Administrative Council per Resolution No. 4, s. 2011, dated 25 January 2011)

Rationale

The University Review Center has started its operations since May 2002. It is almost seven (7) years now that the honorarium of reviewers of Two Hundred Fifty Pesos (250.00 Php) per hour has been implemented. In order to further motivate the reviewers thus effectively inculcate knowledge to the reviewees, it is proposed to increase their honorarium to Three Hundred Fifty Pesos (350.00 Php) per hour. This is a way to raise morale of the faculty members who have put their time and effort in improving the quality of our review center.
