A RESOLUTION APPROVING THE APPOINTMENTS OF DR. EDGARDO E. TULIN AND DR. ANTONIO L. ACEDO, JR. TO THE VACANT POSITIONS OF UNIVERSITY PROFESSOR *SUBJECT TO* EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of departments, faculty members and other officials and employees of the University";

WHEREAS, the University now has two (2) vacant academic positions of University Professor on account of the retirement from active government service of Dr. Paciencia P. Milan (former VSU President) last 27 January 2012 and Dr. Lutgarda S. Palomar last 31 October 2012;

WHEREAS, the PASUC Screening Committee composed of Dr. Feliciano S. Rosete, Chairman (*Rater 1*); Dr. Ruperto S. Sangalang, Member (*Rater 2*); and Dr. Saturnino M. Ocampo, Jr., Member (*Rater 3*) went over the accomplishments of both Dr. Edgardo E. Tulin and Dr. Antonio L. Acedo, Jr., and found both VSU faculty members qualified for the academic position of University Professor;

WHEREAS, the Academic Personnel Board (APB) has endorsed the appointments of Dr. Edgardo E. Tulin and Dr. Antonio L. Acedo, Jr. for the two (2) vacant University Professor positions; and

WHEREAS, the Governing Board thoroughly discussed the merits of the proposal and found it in order.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the appointments of Dr. Edgardo E. Tulin and Dr. Antonio L. Acedo, Jr. to the two (2) vacant positions of University Professor effective upon approval of the Board of Regents and *subject to* existing rules, regulations and guidelines governing such appointments.
