BOR RESOLUTION NO. 36, s. 2012

A RESOLUTION ENDORSING THE PROPOSED 2013 BUDGET OF THE VISAYAS STATE UNIVERSITY (VSU), VISCA, CITY OF BAYBAY, LEYTE IN THE AMOUNT OF FOUR HUNDRED TWENTY-NINE MILLION ONE HUNDRED THREE THOUSAND PESOS (PhP 429.103 Mil)

WHEREAS, the Visayas State University was created by virtue of Republic Act 9437 last April 27, 2007 which renamed the Leyte State University (created by virtue of Republic Act 9158 last 11 August 2001) which, in turn, converted the then Visayas State College of Agriculture (ViSCA) into a state university;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University "To exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Paragraph (a), Section 7 of R.A. 9158 provides: "To enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University";

WHEREAS, the proposed budget has been presented and deliberated upon in the Special University Administrative Council (UADCO) meeting held at the Philippine Root Crops Research and Training Center, VSU Main Campus, Visca, City of Baybay, Leyte last 23 May 2012;

WHEREAS, the UADCO has found that the proposed VSU Budget for FY 2013 to be reasonable and true to the budgetary requirements of the University which will undoubtedly redound to the realization of the University's Mission and Vision, thus, is strongly endorsing the proposed Budget for FY 2013 to the VSU Board of Regents for APPROVAL;

WHEREAS, the said 2013 Budget has been perused and reviewed by the Honorable Chairperson and the Honorable Members of the VSU Board of Regents;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to endorse the amount of Four Hundred Twenty-Nine Million and One Hundred Three Thousand (PhP 429.103 Mil) as the VSU Proposed Budget for CY 2013;

RESOLVED FURTHER, to favorably endorse the above-stated budget proposal to the Department of Budget and Management (DBM) and the Commission on Higher Education (CHED) for approval;
