**BOR RESOLUTION NO. 90, s. 2016**

**A RESOLUTION CONFIRMING THE RENEWAL OF APPOINTMENT OF 25  
CONTRACTUAL ADMINISTRATIVE PERSONNEL OF THE VSU MAIN CAMPUS  
FOR THE PERIOD 01 JULY 2016 TO 30 JUNE 2017**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to appoint, upon the recommendation of the President of the University ... faculty members and other officials and employees of the University.*" as stipulated in Section 7, Item (g) of R.A. 9158;

**WHEREAS**, the University requires the services of contractual administrative employees to be able to carry out its mandate as an institution of higher learning;


**WHEREAS**, the Human Resource and Management Office (HRMO) has gone over the list of employees who are recommended for renewal for the period 01 July 2016 to 30 June 2017 *without prejudice to renewal of appointments*, depending on the availability of funds;

**WHEREAS**, the Governing Board, is convinced that the recommendations of the HRMO adheres to thrust of government that only the best and the most fit should be in the government service;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the renewal of appointments of 25 contractual administrative employees for the period 01 July 2016 until 30 June 2017, without prejudice to renewal of appointments.






