**A RESOLUTION APPROVING THE PROPOSAL

**WHEREAS**, the University deems it necessary to conduct frequent monitoring and supervisory visits on its students as a way of ensuring quality education of LSU students;

**WHEREAS**, the University Administrative Council during its 62<sup>nd</sup> Meeting held last 27 March 2007 has strongly recommended the approval of the proposal to levy a Field Practice Monitoring and Supervision Fee from all Field Practice Students, effective 1<sup>st</sup> Semester, SY 2007-2008.




