BOR RESOLUTION NO. 135, s. 2017

A RESOLUTION CONFIRMING THE CANDIDATES FOR GRADUATION, VSU SYSTEM, FOR THE 1st SEMESTER, SY 2017-2018, *PROVIDED THAT*, ALL THE CANDIDATES HAVE COMPLIED WITH ALL THE REQUIREMENTS FOR GRADUATION ON OR BEFORE THE DEADLINE INDICATED IN THE APPROVED ACADEMIC CALENDAR FOR SCHOOL YEAR 2017-2018

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...";

WHEREAS, the list of candidates for graduation from the different campuses of the VSU System for the 1st Semester, SY 2017-2018 was presented to the University Academic Council for review and approval on the occasion of the 42nd UAC Meeting held last 13 November 2017;

WHEREAS, the University Academic Council approved the List of Candidates for Graduation for the 1st Semester, SY 2017-2018, VSU System, on the occasion of the 42nd UAC Meeting held last 13 November 2017 at the 1/F, Center for Continuing Education (CCE), VSU Main Campus, City of Baybay, Leyte;

WHEREAS, the UAC is strongly endorsing the List of Candidates for Graduation to the VSU Board of Regents for Confirmation, *Provided that*, all the candidates shall have complied with all of the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2017-2018.
