**A RESOLUTION APPROVING THE PROPOSED GUIDANCE MANUAL
OF THE VISAYAS STATE UNIVERSITY**

WHEREAS, the Visayas State College of Agriculture (ViSCA) converted into the Leyte State University (LSU) by virtue of Republic Act 9158 last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (a) of R.A. 9158 empowers the Board of Regents of the University *"to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University"*;

WHEREAS, the University Student Services Office (USSO) is the frontline office created to plan, coordinate, supervise and evaluate programs and services that concern the students' welfare, development and assistance;

WHEREAS, the Guidance is a continuous, sequential and educational process;

WHEREAS, Republic Act No. 9258 otherwise known as the Guidance and Counseling Professional Law was passed to professionalize guidance and counseling involving the integrated approach to the development of a well-functioning individual primarily by helping him/her to utilize his/her potentials to the fullest and plan his/her present and future in accordance with his/her abilities, interests and needs;

WHEREAS, the CHED passed CHED Memorandum No. 9, s. 2013 otherwise known as the Enhanced Policies and Guidelines on Student Affairs and Services, upon which the VSU Guidance Program relies heavily on; and

WHEREAS, the proposal was discussed and approved on the occasion of the 121st UADCO Meeting held last 24 August 2016 at 1st Floor, Center for Continuing Education (CCE), VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed Guidance Manual of the Visayas State University.






