**A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE
MEMORANDUM OF AGREEMENT AND USUFRUCT AGREEMENT ENTERED
INTO BY AND BETWEEN THE VISAYAS STATE UNIVERSITY (VSU) AND THE
DEPARTMENT OF TRADE AND INDUSTRY VIII (VIII) ON THE SHARED
SERVICE FACILITIES PROJECT**

WHEREAS, the Visayas State University is an institution of higher learning established under Presidential Decree No. 400 as amended by Presidential Decree No. 700 and converted into a state university by virtue of Republic Act 9158 and renamed as Visayas State University by virtue of Republic Act 9437;

WHEREAS, the Department of Trade and Industry VIII is an agency of the national government;

WHEREAS, Section 7(t) of R.A. 9158 specifically empowers the VSU Board of Regents to *“develop academic arrangements for institutional capability building with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/specialists as consultants, or visiting or exchange professors, scholars, researchers, as the case may be”*;

WHEREAS, Micro, Small and Medium Enterprises (MSME) Development is a key strategy to achieve the Government’s goal of inclusive growth and job generation;

WHEREAS, the Shared Service Facilities project aims to improve the competitiveness of MSME’s by providing them with machineries, equipment, tools, systems, skills and knowledge under a shared system;

WHEREAS, Republic Act 10964 or the 2018 General Appropriations Act provides for the implementation of the SSF Project that aims to improve the quality and productivity of MSME’s through the procurement of equipment for the intended SSF beneficiaries;

WHEREAS, the SSF project seeks to address the gaps and bottlenecks in the priority industry clusters and will support microenterprises within the priority industry clusters;

WHEREAS, an integral component of the SSF is the execution of a Usufruct Agreement between the DTI-Region VIII and the Visayas State University;

NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Approve the Memorandum of Agreement and Usufruct Agreement entered into by and between the Visayas State University and the Department of Trade and Industry VIII, for the establishment of the Shared Service Facilities (SSF) at the Department of Food Science and Technology (DFST), VSU Main Campus, City of Baybay, Leyte.






