APPROVING THE DONATION OF A MINI BUS FROM THE DEPARTMENT OF AGRICULTURE-AGRICULTURAL TRAINING INSTITUTE REGIONAL TRAINING CENTER 8 AND THE MOTORBIKES AND UTILITY VEHICLES FROM DR. ARTURO E. PASA; RESOLVING FURTHER TO GRANT THE UNIVERSITY PRESIDENT AN AUTHORITY TO SIGN AND EXECUTE THE TERMS IN THE DEED OF DONATION
