PROPOSAL FOR FACULTY MEMBERS TO AVAIL OF STRAIGHT PH.D. PROGRAMS PER VSFC-AS RES. NO. 1860 S. OF 2020

RATIONALE

Under the existing scholarship policy of the university, faculty members can only be allowed to go on study leave with pay to pursue a doctoral degree after he/she has rendered return service for his/her previous study leave grant to pursue master's degree. However, in recent years, scholarship funding institutions, especially abroad, may already grant PhD scholarship for a straight PhD to their students who show exemplary academic performance during their master's degree. There are cases when the grant is given to the student before he/she graduates from the master's degree, or immediately after completing the master's degree. These are very rare opportunities for our excellent faculty to avail of a continuing scholarship and get a PHD with financial support from reputable institutions and saves the university from incurring added cost of faculty development. This is also one way for the university to attain its target of having doctoral degree holders in majority of its faculty workforce in a relatively shorter period of time.

GUIDELINES

- 1. To qualify, any of the following conditions must be met by the faculty:
 - a. Has secured an admission for a straight PhD program, or
 - b. Currently enrolled in a master's degree, but due to excellent academic performance, the school granted him/her the privilege of proceeding to a straight PhD program, without the need to graduate first from the master's degree, or
 - c. Currently enrolled in a master's degree program, but due to excellent academic performance, the host professor, the scholarship sponsor or the university grants him/her a continuing scholarship to proceed to a PhD program <u>immediately</u> after graduating from the master's degree.
- 2. Must sign another contract for conditions b and c.
- 3. Return service is two years per year of study leave with pay.
- For conditions b and c, return service for the master's degree shall be depended until
 completion of the doctoral degree.
