RECTOR'S WORKSHOP TO BE HELD IN BANGKOK, THAILAND ON  
JULY 19, 2006 UNTIL JULY 22, 2006**

**WHEREAS**, the President of the Leyte State University (LSU), Dr. Paciencia P. Milan, has been invited to participate in the World University Presidents Summit 19-22 July 2006 at the Queen Sirikit National Convention Center in Bangkok, Thailand;

**WHEREAS**, Pres. Paciencia P. Milan has also been invited to attend the ASEAN-EU Rectors' Workshop on 22 July 2006 also at the Queen Sirikit National Convention Center in Bangkok, Thailand;

**WHEREAS**, the purpose of the World Summit is to promote closer cooperation among higher education institutions all over the world and to provide opportunities for Presidents, Vice-Chancellors, Rectors, Senior administration teams and high ranking officers to discuss a number of mutually reinforcing developments and issues inside the world of Higher Education;

**WHEREAS**, the ASEAN-EU Rectors' Workshop aims to explore future cooperation between ASEAN and EU and to sustain partnerships and contact between ASEAN and EU university rectors with focus on the offering of joint degree programs including research;

**WHEREAS**, the said invitation requires participants to shoulder the international airfares and the registration fees for attendance in said events which amount to about US\$ 700.00;


**WHEREAS**, the Leyte State University does not have enough funds in its budget to cover said registration fees and international airfares;
