WHEREAS, the Visayas State University was created by virtue of Republic Act 9437 last April 27, 2007 which renamed the Leyte State University (created by virtue of Republic Act 9158 last 11 August 2001) which, in turn, converted the then Visayas State College of Agriculture (ViSCA) into a state university;

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council, to wit: "... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...";

WHEREAS, the University Academic Council, in a Special UAC Meeting last 14 April 2010, has deliberated on this matter and is convinced of the necessity of holding a special graduation ceremony for the 1st Batch of graduates of the BS Nursing program this coming 06 June 2011 in the Main Campus;

WHEREAS, the UAC is strongly recommending, for Approval by the VSU Board of Regents, the holding of a Special Graduation Ceremony for the 1st Batch of graduates of the BS Nursing program on 06 June 2011.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to APPROVE the holding of a Special Graduation Ceremony for the 1st Batch of Graduates of the Bachelor of Science in Nursing on 06 June 2011 in the VSU Main Campus, *Provided that*, this will be the only request that will ever be entertained by the VSU Board of Regents.
