A Referendum Approving the Foreign Travel of Dr. Paciencia P. Milan to Germany for the Period October 1-15, 2007

WHEREAS, the BSH Bosch und Siemens Hausergate GMBH has tendered an invitation to Prof. Dr. Paciencia P. Milan and Prof. Dr. Roberto C. Guarte to visit Germany within the month of October 2007;

WHEREAS, it was proposed and approved that the visit will commence on October 1, 2007 until October 15, 2007;

WHEREAS, the proposed visit will provide an opportunity to further deepen the existing close ties between the Visayas State University and BSH as attested by the development and commercialization of the PROTOS plant oil stove;


