**A Resolution Approving the English  
Learning Program at the Visayas State University**

**WHEREAS**, there are many foreigners from non-English speaking countries who come to the Philippines to learn how to speak, read and write in English;

**WHEREAS**, among the reasons why foreigners come to the Philippines to learn English include the high competence of Filipinos in the English Language and the relatively low cost of learning the language;

**WHEREAS**, the Visayas State University (VSU) has competent faculty and staff who can be tapped as teachers for short-term English language courses;

**WHEREAS**, VSU has an edge over other institutions in the offering of short-term English courses on account of its faculty and staff, facilities, strategic location and access to panoramic and tourist spots in the Region;


**WHEREAS**, this short-term English course is intended for English learners from People's Republic of China, South Korea, and Japan.


**WHEREAS**, the University Administrative Council during its 65<sup>th</sup> UADCO Meeting, approved the proposed English Learning Program at the Visayas State University.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the proposed Guidelines on English Learning Program at the Visayas State University.




