PROPOSAL TO PROVIDE FINANCIAL ASSISTANCE TO STUDENT INTERNS AND FACULTY PURSUING GRADUATE STUDIES WHO ARE STRANDED IN AREAS OUTSIDE REGION VIII BECAUSE OF THE ENHANCED COMMUNITY QUARANTINE (ECQ) DUE TO THE COVID-19 PANDEMIC

Due to the Enhanced Community Quarantine (ECQ) brought about by the COVID-19 pandemic, 16 BS Agribusiness students fielded for their internship/OJT were stranded in Luzon and some parts of Central and Western Visayas since March 14, 2020. Additionally, there are also 2 faculty members who are on study leave in universities outside the region who were unable to go home during the ECQ.

The aforementioned student interns and faculty are requesting for financial assistance from the university to defray the unforeseen added expenses they have incurred and will continue to incur during the duration of the ECQ.

QUALIFICATIONS

Student Interns: Source of Fund: Student Development Fund

- Must be officially enrolled this 2nd semester 2019-2020
- 2. Undergoing internship/OJT during the implementation of the ECQ and has not finished the internship as of March 10, 2020.
- Must not be a resident of the place where he/she is staying now during the ECQ.

Faculty on Study Leave: Source of Fund: VSU Scholarship Fund (GAA)

- Must be enrolled in the 2nd semester that covers November to March 2020, or in the 2nd trimester covering December 2019 to March 2020.
- Must be enrolled as a regular student in his/her graduate program during the 2nd semester 2019-2020. Or he/she is not an overstaying student.
- 3. Must be under the VSU Fellowship Grant/not enjoying external scholarship.
- 4. Must not be resident of the place where he/she is staying now during the ECQ.

FINANCIAL ASSISTANCE

Student Interns: A one-time cash assistance of P5,000 per student for those stranded in Negros and Iloilo, P10,000 for those in Metro Manila, Cavite, Bulacan, Quezon province; and P15,000 for those stranded in Benguet.

Faculty on Study Leave: Two months stipend covering the months of April and May 2020
