A RESOLUTION CONFIRMING THE APPOINTMENT TO REGULAR PLANTILLA ITEM POSITIONS EIGHT (8) ADMINISTRATIVE STAFF FROM THE MAIN CAMPUS AND TOLOSA CAMPUS SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the University regularly provides regular plantilla items to its administrative employees whenever there are available;

WHEREAS, the Office of the Director for Administration and Human Resource Development (ODA-HRD) strongly recommend that the eight (8) administrative personnel be given regular plantilla item positions, effective on the date indicated, as follows:
