BOR RESOLUTION NO. 132, s. 2016

A RESOLUTION APPROVING THE NEW APPOINTMENTS OF THREE (3) CASUAL ADMINISTRATIVE PERSONNEL, VSU MAIN CAMPUS AND EFFECTIVE ON THE DATES INDICATED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "*to appoint, upon the recommendation of the President of the University ... faculty members and other officials and employees of the University.*" as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University requires the services of casual administrative employees to be able to carry out its mandate as an institution of higher learning;

WHEREAS, the Human Resource and Management Office (HRMO) has gone over the list of employees who are recommended for renewal for the period 01 August 2016 to 31 December 2017 *without prejudice to renewal of appointments*, depending on the availability of funds;

WHEREAS, the Governing Board, is convinced that the recommendations of the HRMO adheres to thrust of government that only the best and the most fit should be in the government service;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the issuance of New Appointments of three (3) casual administrative employees for the period 01 August 2016 until 31 December 2016, without prejudice to renewal of appointments.
