A RESOLUTION APPROVING THE CHARGING OF A SUPERVISION FEE OF ONE THOUSAND PESOS (P1,000.00) IN HRTM 200 – INDUSTRY PRACTICE EFFECTIVE 2nd SEMESTER, SCHOOL YEAR 2008-2009

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix the tuition fees and other necessary school fees and charges such as, but not limited to, matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultations with the involved sectors" as stipulated in Item (d), Section 7 of R.A. 9158;

WHEREAS, there is a need to charge a Supervisory Fee to students in view of the increasing cost of sustaining the supervision of HRTM senior students fielded on Industry Practice;

WHEREAS, the University Administrative Council unanimously approved the charging of a P1,000.000 supervision Fee on all students enrolling in HRTM 200 – Industry Practice during the 73rd UADCO Meeting held last 28 November 2008 at the FARMI Conference Room, VSU Main Campus, Visca, City of Baybay, Leyte.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the charging of a P1,000.000 supervision Fee on all students enrolling in HRTM 200 – Industry Practice effective in the 2nd Semester, School Year 2008-2009.
