**BOR RESOLUTION NO. 26 , s. 2013**

**A RESOLUTION CONFIRMING  
THE APPOINTMENTS OF SOME UNIVERSITY  
PERSONNEL TO VACANT ADMINISTRATIVE POSITIONS  
EFFECTIVE ON THE DATES INDICATED UNTIL 31 DECEMBER 2013**

**WHEREAS**, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board “to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University”;

**WHEREAS**, the University needs to periodically assess the efficiency and effectiveness in the delivery of its services to its clientele;

**WHEREAS**, the University has found it necessary to appoint University personnel to key positions as the need arises brought about by sabbatical leaves of absence by faculty as well as by retirement and/or leaves of absence of administrative personnel to enable the University to continue to provide a more responsive service to the University’s clientele;

**WHEREAS**, the Non-Academic Personnel Board (NAPB) has reviewed the qualifications of the prospective appointees to key positions and has found the personnel to be in possession of the needed experience and skills to effectively and efficiently deliver the required service to the University and its clientele, as follows:

1. Dr. Lualhati M. Noriel – *OIC Vice President for Instruction* – effective 04 May 2013 until a new VP for Instruction shall have been designated;
2. Dr. Christina A. Gabrillo – *Head, Radio Station DYAC* – effective 16 May 2013 until 31 December 2013;
3. Prof. Francisco G. Gabunada, Jr. – *IGP Director* – effective 05 June 2013 until 31 December 2013;




