BOR RESOLUTION NO. 54, s. 2010

A RESOLUTION APPROVING THE GUIDELINES ON DEPLOYMENT OF VSU FACULTY AND STAFF TO OTHER UNITS OF THE UNIVERSITY

WHEREAS, the Visayas State University is one of the acknowledged institutions of higher learning in the Philippines;

WHEREAS, in its desire to continue to be among the best academic institutions of higher learning in the country, the VSU needs to maximize the utilization of its high-level manpower complement to buttress its trilogy of functions: instruction, research and extension;

WHEREAS, some units of the University have long been practicing the tapping of critical manpower belonging to other units within the University to "fill-in" its need for manpower with particular expertise for instruction, research and extension activities;

WHEREAS, the University is now facing serious manpower shortfalls on account of the rapid expansion of the University's curricular programs despite the lack on new plantilla positions for faculty manning the different degree programs;

WHEREAS, research centers oftentimes tap the expert services of faculty members from academic departments who have the needed expertise and experience to handle some of their research/extension projects;

WHEREAS, Section 10 of R.A. 9158 provides that the Administrative Council "review and recommend to the Board (of Regents) policies governing the administration, management and development planning of the University"; and

WHEREAS, the University Administrative Council, on the occasion of its 26th UADCO Meeting held at the FARMI Training Hall last 14 September 2010 approved the proposal and is recommending the approval of the proposal by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed Guidelines on Deployment of VSU Faculty and Staff to other Units of the University, as proposed.
