A RESOLUTION APPROVING THE RECLASSIFICATION OF THE ACADEMIC RANK OF DR. JOSE L. BACUMSO TO UNIVERSITY PROFESSOR SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH AN APPOINTMENT

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the University President has submitted himself evaluation for the academic position of University Professor under Special Common Criteria for Evaluation (CCE) Areas pursuant to NBC 461 for SUC Presidents;

WHEREAS, the Screening Committee, Chaired by Hon. CHED Commissioner, Dr. William C. Medrano rated the accomplishments of incumbent VSU President, Dr. Jose L. Bacusmo to be more than sufficient to qualify him for the academic position of University Professor;

WHEREAS, the other members of the Screening Committee were Dr. Lauro B. Tacbas, President of PASUC, and Dir. Edgardo M. Macaranas of the Department of Budget and Management were in agreement with the results of the screening;

WHEREAS, the University President has been awarded the academic rank of University Professor "on or after 07 April 2011" and is seeking approval of said appointment from the Board of Regents subject to existing rules, regulations and guidelines governing such an appointment.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the new academic rank of the VSU President, Dr. Jose L. Bacusmo to University Professor effective upon Board approval.
