BOR RESOLUTION NO. 19, s. 2014

A RESOLUTION COURSED THROUGH A REFERENDUM CONFIRMING THE CANDIDATES FOR GRADUATION FROM THE DIFFERENT CAMPUSES OF THE VSU SYSTEM FOR THE 2nd SEMESTER, SY 2013-2014 *PROVIDED* THAT, ALL THE CANDIDATES SHALL HAVE COMPLIED WITH ALL THE REQUIREMENTS FOR GRADUATION ON OR BEFORE THE DEADLINE INDICATED IN THE APPROVED ACADEMIC CALENDAR FOR SCHOOL YEAR 2013-2014

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board “*to set policies on admission and graduation of students*”;

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: “... *review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board*...”;

WHEREAS, the University Academic Council, has reviewed the list of candidates for graduation from the different campuses of the VSU System for the 2nd Semester, SY 2013-2014; and


