BOR RESOLUTION NO. 79, s. 2015

A RESOLUTION CONFIRMING THE UPGRADING OF TWO (2) ADMINISTRATIVE STAFF FROM THE VSU MAIN SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS AND EFFECTIVE ON THE DATES INDICATED

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the Visayas State University periodically upgrades some administrative positions as a result of the abolition and/or collapsing of positions which the University finds insignificant to augment the salaries assigned to the upgraded position;

WHEREAS, Paragraph k, Section 4 of Rule III of the Omnibus Rules on Appointments and Other Personnel Actions provide:

"Upgrading refers to the change in position title with the corresponding increase in salary grade. Positions are upgraded in order to attain effectively the functions and duties attached to the position and for the employee to perform an all-around adaptability in meeting diverse work assignments. This requires issuance of appointment";

WHEREAS, the Non-Academic Personnel Board (NAPB), the Selection and Promotion Board for Administrative Personnel of the Visayas State University, met several times at the Conference Room of the Vice-President for Administration and Finance for the purpose of deliberating on upgrading of the positions of five (5) administrative staff due to their increased responsibilities;

WHEREAS, the NAPB, after careful deliberation found the request in order and is strongly recommending to the Department of Budget and Management (DBM), the upgrading of the following personnel:

- Mr. Lorbert G. Mazo from Administrative Aide I (SG-1) to Laboratory Technician I (SG-6); and
- 2. Ms. Leilani M. Valdevieso *from* Administrative Aide I (SG-1) to Laboratory Technician I (SG-6).
