**A RESOLUTION
APPROVING THE PROPOSED
STUDENT HANDBOOK OF THE COLLEGE OF NURSING**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, Section 7, Paragraph (i) of R.A. 9158 empowers the Governing Board "*to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided*";

WHEREAS, Section 10 of Republic Act No. 9158 – The Administrative Council – stipulates, to wit: "*There shall be an administrative council consisting of the President of the University as Chairman, the Vice-Presidents, Deans, Directors and other officials of equal rank as Members, and whose duty is to review and recommend to the Board (of Regents) policies governing the administration, management and development planning of the University*";

WHEREAS, there is a need for the College of Nursing to come-up with their own Student Handbook which will embody the Ideals, Goals and Aspirations of the College;

WHEREAS, the Student Handbook also contains the Rules, Guidelines and Expected Responsibilities that all BS Nursing students are expected to internalize and remember in their pursuit of an academic program that is exciting, challenging, highly valued and professionally rewarding;

WHEREAS, the University Administrative Council (UADCO) discussed and approved "*in-principle*" the proposal on the occasion of the 91st UADCO meeting held at the PhilRootcrops Training Hall last 26 August 2011 subject to the submission of the Final Copy of the Student Handbook in the next regular UADCO Meeting;

WHEREAS, the Dean of the College of Nursing resubmitted to the UADCO the Final Copy of the Student Handbook for the College of Nursing on the occasion of the 92nd UADCO Meeting held last 13 October 2011 at the PhilRootcrops Training Hall and passed UADCO Resolution No.


31, s. 2011 "Approving the Proposed Student Handbook of the College of Nursing, effective upon Board approval."


THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed Student Handbook of the College of Nursing, effective upon Board Approval.
