APPROVING THE APPOINTMENTS OF PERSONNEL TO ADMINISTRATIVE POSITIONS WITH SALARY GRADE 18 AND ABOVE AS PRESENTED AND FURTHER AUTHORIZES THE UNIVERSITY PRESIDENT TO SIGN THE APPOINTMENT PAPER

Whereas, the Non-Academic Personnel Board (NAPB) endorsed to the University President the results of the selection process for various administrative positions;


