A RESOLUTION CONFIRMING THE CHANGE IN
POSITION TITLE OF MS. MERLE N. GRAVADOR FROM
ADMINISTRATIVE AIDE I (CASUAL) TO ADMINISTRATIVE AIDE III
(CASUAL) AND MS. MA. FE L. LIMSIACO FROM ADMINISTRATIVE AIDE II
(CASUAL) TO ADMINISTRATIVE AIDE IV (CASUAL) EFFECTIVE ON THE DATES
INDICATED AND SUBJECT TO EXISTING RULES, REGULATIONS AND
GUIDELINES

**WHEREAS**, the University is granted lump sum appropriation for salaries and wages of contractual personnel who will be performing functions that cannot be handled by the regular employees;

WHEREAS, Section 2, par. F, Rule III of the Revised Omnibus Rules on Appointments and Other Personnel Actions under Civil Service Commission Memorandum Circular No. 40, s. 1998 provides, to wit:

"f. Casual – Issued for essential and necessary services where there are not enough regular staff to meet the demands of the service"

WHEREAS, the Non-Academic Personnel Board (NAPB), the Selection and Promotion Board for Administrative Personnel of the Visayas State University, has determined that both employees are underpaid based on their actual functions;

WHEREAS, the NAPB, after careful deliberation during in its meetings held last 24 January 2012 at the Conference Room of the Vice-President for Administration and Finance, decided to change the position titles of the two administrative personnel that most closely fit their actual functions, as follows:

- 1) **Ms. Merle N. Gravodor**, from Administrative Aide I (*Casual*) to Administrative Aide III (*Casual*), based on his qualifications, experience and years of service to the University;
- 2) Ms. Ma. Fe. L. Limsiaco, from Administrative Aide II (Casual) to Administrative Aide IV (Casual), based on his qualifications, experience and years of service to the University;

**WHEREAS**, the University President is strongly recommending the change in the position titles of the two (2) administrative employees and is endorsing the same to the Board of Regents for Confirmation *subject to* existing rules, regulations and guidelines governing such appointments.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the change in position title of Ms. Merle N. Gravodor to Administrative Aide III (Casual) and Ms. Ma. Fe L. Limsiaco to Administrative Aide IV (Casual).
