#### BOR RESOLUTION NO. 83, s. 2016

## A RESOLUTION APPROVING THE PROPOSED INCREASE IN THE ALLOWANCE OF VARSITY ATHLETES DURING ATHLETIC MEETS CHARGED AGAINST STUDENT ATHLETIC FEES

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University "to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

**WHEREAS**, the Governing Board passed BOR Resolution No. 77, s. 2002 providing Guidelines for the implementation of University-funded financial privileges and grants (non-academic):

WHEREAS, there is a need to increase the allowance given to Varsity athletes who actively compete during athletic meets from P150.00 to P300.00 for the whole duration of the Meet charged against Student Athletic Fees; and

WHEREAS, the proposal was discussed and approved on the occasion of the 121<sup>st</sup> UADCO Meeting held last 24 August 2016 at 1<sup>st</sup> Floor, Center for Continuing Education (CCE), VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed increase in the allowance of Varsity Athletes during athletic meets from P150.00 to P300.00 for the whole duration of the Meet, charged against Student Athletic Fees.
