PROPOSAL TO AMEND THE GUIDELINES OF THE VSU PUBLICATION INCENTIVE SYSTEM

(As approved by the Board of Regents per Board Resolution No. 60, s. 2013, dated September 6, 2013)

Rationale

The Publication Incentive Committee during its meeting on May 4, 2012 noticed that the effectivity of giving the publication incentive is not clearly stated in the approved guideline. The amendment of the guideline is deemed necessary to avoid problems in the future especially when it comes to COA rules. Hence, this proposal is made.

The award is open to all articles published only in peer-reviewed journals, books published by recognized publishers, including Oxford, Cambridge, MacMillan, Blackwell, Rourledge, Harcourt, Brace and Co., Elsevier, National Bookstore, Rex Bookstore, Goodwill Publishing and other recognized publishing houses. However, the articles and books should have been published in that year only. For example, for 2009, only those that were published in 2009 are qualified for the award. - Only faculty members or researchers who are the first or corresponding authors of the article are qualified to apply for the award.
- Only faculty members or researchers who are the first author or corresponding author of the article are qualified for the award.
