BOR RESOLUTION NO. 31, s. 2011

**A RESOLUTION APPROVING
THE PROPOSED REVISED RATES
FOR THE USE OF DIFFERENT VSU FACILITIES**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University *"shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents"*;

WHEREAS, Section 7 of R.A. 8292 empowers the Board to *"exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines"*;

WHEREAS, among other powers granted to the Board of Regents is the power *"to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University"* as stipulated in Section 7, Paragraph (a) of R.A. 9158;

WHEREAS, the University maintains a substantial number of infrastructure in the Main Campus as well as Liaison Offices in Cebu and Manila which also serve as *"home away from home"* of University employees who travel to Cebu and Manila";

WHEREAS, the cost of maintaining these University facilities have been increasing on account of the skyrocketing prices of materials needed to maintain them;

WHEREAS, the proposed increase in the rates for the use of various University infrastructure and facilities were presented during the 88th University Administrative Council Meeting held last 25 January 2011 at the 2nd Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte;


WHEREAS, the UADCO passed UADCO Resolution No. 3, s. 2011 dated 25 January 2011 approving the Revised Rates for the Use of Different VSU Facilities, as proposed and strongly endorsing the same to the VSU Board of Regents for Approval.


