WHEREAS, the Office of the President of the Leyte State University interposes no objection to the Special Detail of Col. Ricardo M. Colina as Chief Security Officer of the University;

WHEREAS, in consideration of the additional services of Col. Colina as Chief Security Officer of the LSU, the Administration deems it equitable to provide him with a monthly honorarium of P2,000.00 to be sourced from the University's Income;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the Special Detail of Col. Ricardo M. Colina to the Leyte State University to act as Chief Security Officer of University effective 01 June 2006.
