## BOR RESOLUTION NO. 48, s. 2023

## A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE FINAL LIST OF THE CANDIDATES FOR GRADUATION AND CANDIDATES WITH LATIN HONORS OF THE VSU MAIN CAMPUS FOR THE SECOND SEMESTER OF SCHOOL YEAR 2022-2023

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS,** Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

WHEREAS, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

WHEREAS, a total of one thousand two hundred four (1,204) students from the VSU Main Campus have satisfactorily complied with the requirements for graduation for the second semester of school year 2022-2023;

**WHEREAS,** there is a total of one thousand one hundred fifty-three (1,153) candidates for graduation from the undergraduate degree programs of the university;

**WHEREAS,** a total of fifty-one (51) graduate students have complied with the requirements for graduation from the university's different graduate degree programs;

WHEREAS, among the one thousand one hundred fifty-three candidates for the undergraduate programs, three hundred eighty (380) have graduated with Latin Honors where two (2) have attained the distinction of Summa Cum Laude, fifty-one (51) have attained the distinction of Magna Cum Laude, while three hundred twenty-seven (327) have attained the distinction as Cum Laude;

**WHEREAS,** the list of the candidates for graduation and the list of candidates with Latin Honors were deliberated and approved by the University Academic Council during its 29 May 2023 at the VSU RDE Hall;
