BOR RESOLUTION NO. 80, s. 2008

A RESOLUTION APPROVING THE GUIDELINES FOR THE GRANT OF PERMANENT TENURE OF ACADEMIC FACULTY

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, there is a need to revise the existing Codal Provisions related to the grant of Permanent Tenure on academic faculty in the light of the conversion of the college into a university;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Item (a), Section 7 of R.A. 9158:

WHEREAS, the University Administrative Council, on the occasion of its 73rd UAdCO Meeting held at the FARMI Conference Room, VSU Main Campus, Baybay, Leyte last 28 November 2008, unanimously approved the "Guidelines for the Grant of Permanent Tenure on Academic Faculty" including the "automatic conversion from Temporary Status to Permanent Status of all academic faculty who have attained the rank of at least Assistant Professor I, upon the initial implementation of the new Guidelines, effective upon Board Approval".

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Guidelines for the Grant of Permanent Tenure on Academic Faculty including the automatic conversion from Temporary Status to Permanent Status of all academic faculty who have attained the rank of at least Assistant Professor I, upon the initial implementation of the new Guidelines, effective upon BOR approval
