**BOR RESOLUTION NO. 98, s. 2016**

**A RESOLUTION APPROVING THE DEPUTIZATION OF  
PROF. DANIEL M. TUdTUD, JR. AS A SIGNATORY ON  
UNIVERSITY-ISSUED CHEQUES IN THE VSU MANILA OFFICE**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to enact rules and regulations , not contrary to law, as may be necessary to carry out the purposes and functions of the University*", as stipulated in Section 7, Item (a) of R.A. 9158;

**WHEREAS**, the Head of the VSU Manila Office, Ms. Delia L. Silao, is retiring by 25 September 2016;

**WHEREAS**, no other person can be given the task of having to sign all the cheques all the time upon the retirement of Ms. Silao;

**WHEREAS**, Prof. Daniel M. Tudit, Jr., Vice President for Planning, Resource generation and External Affairs, also has direct supervision of the VSU Manila Office;

**WHEREAS**, Prof. Tudit has indicated that he interposes no objection to becoming the signatory for University-issued cheques in Manila to hasten the payments due to suppliers of goods and services needed by the University; and

**WHEREAS**, the Governing Board understands the need to issue cheques to facilitate the payment of suppliers of goods and services to the University.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the deputization of Prof. Daniel M. Tudit, Jr. as signatory of University-issued cheques in VSU Manila Office.




