A RESOLUTION APPROVING
THE GUIDELINES ON THE IMPLEMENTATION
OF THE STUDY GRANT FOR BARANGAY OFFICIALS
AND THEIR
DEPENDENTS AND THE CHAIRMAN
OF THE SANGGUNIANG KABATAAN TO IMPLEMENT SECTION 393 (b),
PARAGRAPH 4 and SECTION 434 OF THE LOCAL GOVERNMENT CODE of 1991

WHEREAS, the 1987 Philippine Constitution mandates that the State shall establish and maintain a system of scholarship grants, student loan programs, subsidies and other incentives which shall be made available to deserving students in both public and privates educational institutions;

WHEREAS, Section 393 (b), Paragraph 4 and Section 434 of the Local Government Code of 1991stipulate the educational benefits that barangay officials and their dependents and the Chairman of the Sangguniang Kabataan;

WHEREAS, the Leyte State University is a public higher education institution financed and supported by the government of the Republic of the Philippines;

WHEREAS, the Leyte State University is authorized to draft guidelines covering scholarship and study grant programs that it extends to students intending to enroll or those already enrolled;

WHEREAS, the University Student Services Office has drafted guidelines covering students intending to enroll in LSU including those who may qualify under Section 393 (b), Paragraph 4 and Section 434 of the Local Government Code of 1991;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed Guidelines on the Implementation of the Study Grant for Barangay Officials and their Dependents and the Chairman of the Sangguniang Kabataan to implement Section 393 (b), Paragraph 4 and Section 434 of the Local Government Code of 1991, as presented, effective in the 1st Semester of SY 2006-2007.
