BOR RESOLUTION NO. 35, s. 2009

A RESOLUTION APPROVING THE EXTENSION OF OF THE COLLEGE OF AGRICULTURE FINANCIAL ASSISTANCE PROGRAM FOR ANOTHER FOUR YEARS OR UNTIL SY 2012-2013

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Item (a), Section 7 of R.A. 9158;

WHEREAS, the College of Agriculture (CA) has offered an attractive Financial Assistance Program to poor but deserving students enrolled in any degree program offered by academic departments under the College;

WHEREAS, the CA has been carefully monitoring the implementation of the CA-FAP the past four years and has found a dramatic decline in the number of students still covered by the CA-FAP;

WHEREAS, the College of Agriculture feels there is a need to improve extend the life of the CA-FAP for another four years or until SY 2012-2013;

WHEREAS, the University Administrative Council during its 76th UADCO Meeting held last 11 June 2000 has recommended the approval of the extension of the CA-FAP for another four years or until SY 2012-2013, effective upon BOR approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed extension of the CA-FAP for another four years or until SY 2012-2013, effective upon BOR approval.
