A RESOLUTION APPROVING THE ADOPTION OF CHED MEMORANDUM ORDER (CMO) NO. 44, s. 2006 (BACHELOR OF SCIENCE IN FORESTRY CURRICULUM)

WHEREAS, the Commission on Higher Education (CHED) issued CMO No. 44, s. 2006 also known as "Revised Policies and Standards for the Bachelor of Science in Forestry" in order to implement the new BS Forestry curriculum;

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "*to set policies on admission and graduation of students*";

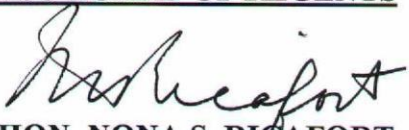
WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "It shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college *subject to* appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

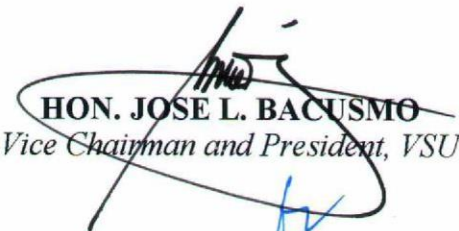
