## BOR RESOLUTION NO. 103, s. 2015

A RESOLUTION APPROVING THE REQUEST OF
PRESIDENT EDGARDO E. TULIN FOR AUTHORITY TO TRAVEL
TO AUSTRALIA CHARGED TO HIS LEAVE CREDITS FOR THE PERIOD
20 DECEMBER 2015 UNTIL 07 JANUARY 2016 SUBJECT TO EXISTING RULES AND
REGULATIONS GOVERNING FOREIGN TRAVELS BY GOVERNMENT OFFICIALS

WHEREAS, the University President is requesting that he be allowed to travel to Australia with his family from 20 December 2015 until 07 January 2016;

WHEREAS, President Edgardo E. Tulin and his family already had planned on taking a short family vacation in Australia last December 2014 which had to be rescheduled on account of heavy work pressure in the University;

**WHEREAS**, the University President has indicated that he would like to take the opportunity to embark on the planned family vacation to Australia on account of the fact that the round trip plane tickets from Manila to Australia and back will be expiring by the end of December 2015 if these are not used before this time:

WHEREAS, President Edgardo E. Tulin has filed a leave-of-absence charged to his accrued leave credits, for the duration of his travel to Australia;

WHEREAS, all expenses attendant to President Tulin's travel to Australia will be personally borne by him and no University funds will be used for this purpose;

**NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to Approve the request of President Edgardo E. Tulin for authority to travel to Australia for the period 20 December 2015 until 07 January 2016, charged to his leave credits *subject to* existing rules and regulations governing foreign travels by government officials.
