## **BOR RESOLUTION NO. 49 SERIES OF 2024**

A RESOLUTION APPROVING THE APPOINTMENT OF MR. MIKE LAURENCE V. LUMEN AS EXECUTIVE ASSISTANT III (SG 20) OF VISAYAS STATE UNIVERSITY ON COTERMINUS STATUS SUBJECT TO CIVIL SERVICE COMMISSION (CSC) PERTINENT RULES AND REGULATIONS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS,** Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

WHEREAS, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

WHEREAS, DBM National Budget Circular No. 589 dated 25 May 2022 on Revised Organization and Staffing Standards (OSS) for SUCs Phase 1 opens a vacancy for the Executive Assistant III (SG 20) position on coterminous status at Visayas State University;

**WHEREAS,** Mr. Mike Laurence V. Lumen applied for the Executive Assistant III position at Visayas State University with all educational requirements, trainings, work experience, and eligibility complied;

**WHEREAS,** the VSU Administrative and Academic Committee discussed and endorsed Mr. Lumen's application to the Full Board for approval during its 25 March 2024 meeting at CHED Regional Office 8 in Tacloban City;
