BOR RESOLUTION NO. 44, s. 2016

A RESOLUTION CONFIRMING THE ADOPTION OF THE EXISTING BORAPPROVED GUIDELINES ON THE USE OF THE UNIVERSITY SWIMMING POOLS

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Section 7, Item (a) of R.A. 9158;

WHEREAS, the University has constructed an additional recreational facility for VSU constituents as well as visitors to the campus, the Molave Hill Olympic Sized Swimming Pool;

WHEREAS, the Governing Board passed BOR Resolution No. 44, s. 2007 dated 01 May 2007 on the occasion of the 29th VSU BOR Meeting held at the Office of the University President, VSU Main Campus, Visca, City of Baybay, Leyte, approving the Guidelines on the Use of the VSU Beach Garden Swimming Pool;

WHEREAS, the proposed Guidelines were carefully thought out in order to insure the safety of the public as well provide adequate protection to the facilities;

WHEREAS, there is a need to levy a fee for the use of such facilities such that it will be able to make a reasonable return to investment;

WHEREAS, at this point in time, the Guidelines approved by the Governing Board are still applicable including the approved rates for the use of the swimming pool facilities;

WHEREAS, the proposal was discussed and approved on the occasion of the 119th UADCO Meeting held last 16 June 2016 at Conference Room, Office of the Vice President for Administration and Finance, 2/F Administration Building, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the adoption of the BOR-approved Guidelines on the Use of the University Swimming Pools.

PROPOSED GUIDELINES IN THE USE OF THE NEW SWIMMING POOL AT MOLAVE HILL

Rationale

The Visayas State University has just completed the construction of an "Olympic-sized" swimming pool located at the Molave Hill, VSU Main Campus. This pool is really intended to be a mixed-use pool, which can be used as a teaching-learning open to the public and as such, require appropriate Guidelines prior to its launching as a public-oriented pool.

The Governing Board passed BOR Resolution No. 44, s. 2007 dated 01 May 2007 entitled" "Guidelines on the Use of the LSU Garden Beach Resort and Swimming Pool." However, in addition to the BOR approved Guidelines, the following revision is proposed:

A. General Guidelines on the Use of the Swimming Pool

Items 1. to 18

Item 19

- revised to wit:

(Pool Closing Time)

4:00 PM for children 5:00 PM for adults

B. Rates

As approved by the Governing Board per BOR Resolution No. 44, s. 2007.

The Institute of Human Kinetics (IHK) may, upon proper representation and after due course, be permitted to use the new swimming pool for instructional purposes and special functions. It is understood that the Institute will assume full-responsibility for their activities.

Proposed Guidelines on the Use of the LSU Garden Beach Resort Swimming Pool

Comments from the VSU-BOR:

The Board suggested that the rate be graduated such that if it will be for a party of less than 50 users, the rent will be P2,000. If there are more than 50 but less than 100 persons, P3,000. If there are more than 100 persons, the P5,000 rent will apply. This is to make the rental rates more affordable. However, those who will use the pool will be charged separately.

GUIDELINES ON THE USE OF THE VSU GARDEN BEACH RESORT SWIMMING POOL

The proposed guidelines and rate shall be enforced uniformly to all users of the pool.

A. General Guidelines on the Use of Swimming Pool

- Persons with any of the following medical conditions shall not be allowed to use the swimming pool.
 - a. An infectious or communicable disease.
 - b. Those with colds, skin eruptions, or open blisters/wounds.
- 2. Everybody is required to take a cleansing shower before using the pool.
- 3. Only swimming attires without buttons, zippers and hooks are allowed.
 - a. Swimming suit for ladies
 - b. Swimming trunk for males
- Street clothes and shirts with sleeves, shoes and sandals are not permitted for swimming.
- Foods and drinks are strictly prohibited around the pool except in designated places.
- 6. Spitting, urinating or other acts that may pollute the pool is prohibited.
- Running or boisterous or rough play is not permitted in the swimming pool enclosure or bathhouse.
- 8. Diving is not allowed.
- 9. Pets or other animals are not permitted within the area.

- 10. Children ten (10) years old and under must be accompanied by a responsible adult.
- 11. Non-swimmers and weak swimmers are restricted to the shallow end of the pool.
- 12. Distracting the lifeguard is prohibited.
- 13. Children in diapers are not allowed in the pool.
- 14. Inflatables are not permitted in the pool. This includes inflatable toys, inner tubes, and rafts.
- 15. Kickboards, fins and snorkels are not permitted. Only goggles are permitted.
- 16. Use or possession of alcohol, illegal drugs and smoking is strictly prohibited.
- 17. During high attendance times, the management requires a ten minutes rest period (up to once per hour) for children. The main purpose of the rest period is to reduce pool contamination by providing users with opportunity to use the restrooms. This is also an opportunity for children to rehydrate and reapply sun block.
- 18. Remove all jewelries before using the pool.
- 19. Pool closing time is:

5:00 P.M. for Children 8:00 P.M. for Adults

B. Rate

1. Adult:

Regular = P. 100.00 (until closing time)
LSU Faculty, staff & students = P 75.00 (until closing time)

- 2. Children (10 years & below) = P 50.00
- 3. Minimum night occupancy: 10 persons

4. Private parties:

Less than 50 users - P2,000.00

More than 50 but less than 100 persons - P3,000.00

More than 100 persons - P 5,000.00

Those who will use the pool will be charged separately.
