**A RESOLUTION APPROVING THE CHANGE
OF APPOINTMENT STATUS OF DR. PABLO B. PEDRERA
(COLLEGE ADMINISTRATOR II) FROM PERMANENT TO TEMPORARY**

WHEREAS, the Visayas State University abides fully with all the Rules and Regulations, Guidelines, and Circulars of the Civil Service Commission (CSC);

WHEREAS, the University System was created on account of the integration of four (4) CHED Supervised Institutions (CSIs) with the then Visayas State College of Agriculture (now the Visayas State University) in 1998;

WHEREAS, on account of the integration, position titles of personnel in the integrated campuses were change to conform with the nomenclature of position titles utilized by State Universities and Colleges;

WHEREAS, the position title of Superintendent was one of the position titles that was dropped in favor of the position title of Campus Administrator;

WHEREAS, the position title of Campus Administrator requires a qualification of Career Executive Service Officer (CESO) eligibility to whoever will be appointed to the said position;

WHEREAS, the incumbent Campus Administrator of VSU Alangalang Campus, Dr. Pablo B. Pedrera, does not possess the required CESO eligibility for him to legally occupy the said position as borne out by the results of the Search Committee created for this purpose;

WHEREAS, it is necessary to appoint a qualified applicant to said position but in the meantime it is necessary to appointment somebody to run the affairs of the Alangalang Campus;

WHEREAS, on account of the lack of eligibility required for the position of Dr. Pablo B. Pedrera, it was the considered view of the Search Committee that Dr. Pedrera be reappointed to the position of Campus Administrator (Temporary Status) in view of his superior knowledge and qualifications in running the affairs of the campus;


