BOR RESOLUTION NO. 46, s. 2018

A RESOLUTION CONFIRMING THE NEW CONTRACTUAL APPOINTMENT OF MR. DELFIN E. CABARDO EFFECTIVE ON THE DATES INDICATED, SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, among other powers granted to the Board of Regents is the power "to appoint, upon the recommendation of the President of the University ... faculty members and other officials and employees of the University." as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University requires the contractual services of Mr. Delfin E. Cabardo to be able to carry out its mandate as an institution of higher learning;

WHEREAS, the Human Resource and Management Office (HRMO) has gone over the list of employees who are recommended for new appointment of Mr. Cabardo for the period 03 January 2019 to 30 June 2019 without prejudice to renewal of appointment, *subject to* the availability of funds; and

WHEREAS, the Governing Board, is convinced that the recommendations of the HRMO adheres to thrust of government that only the best and the most fit should be in the government service.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the new contractual appointment of Mr. Delfin E. Cabardo in the VSU Main Campus, effective on the dates indicated and without prejudice to renewal of appointment, *subject to* the availability of funds.
