#### BOR RESOLUTION NO. 123, s. 2016

A RESOLUTION APPROVING THE VARIOUS MEMORANDUM OF AGREEMENT (MOAs) AND MEMORANDUM OF UNDERSTANDING (MOUS) ENTERED INTO BY AND BETWEEN THE VISAYAS STATE UNIVERSITY (VSU) AND VARIOUS AGENCIES, INSTRUMENTALITIES AND ENTITIES FOR THE PERIOD 01 JANUARY 2016 UNTIL 30 JUNE 2019

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Section 7, Item (a) of R.A. 9158;

WHEREAS, the University regularly "develop consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign in furtherance of the purposes and objectives of the University" as enunciated in Section 7, Paragraph (s) of RA 9158;

WHEREAS, the Visayas State University finds it advantageous to have entered into these different Memorandum of Agreement (MOAs) and Memorandum of Understanding (MOUs) with various agencies, instrumentalities and entities as it has provided benefits to the University and its constituents and more importantly to the general populace of Region VIII and the Philippines at large; and

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the Memorandum of Agreement (MOAs) and Memorandum of Understanding (MOUs) entered into by the Visayas State University and various agencies, instrumentalities and entities for the period 01 January 2016 until 30 June 2019.
