WHEREAS, the LSU-Tolosa Campus is willing to accept the vehicle and is willing to repair and maintain transferred vehicle as best as they can;


WHEREAS, the Main Campus interposes no objection to the immediate transfer of the said Yellow Toyota Hi-Ace;
